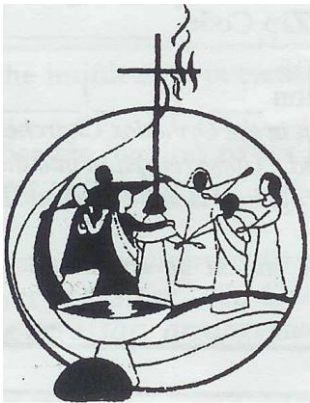

Testimony of Baptism form should be obtained from the Office of the Chancellor. Regarding Baptism in other denominations:

- a. *Orthodox (Greek, Russian, Annenian, etc.): If the fact of Baptism is certain, both Baptism and Confirmation are presumed to be valid, since Confirmation takes place at Baptism in the Orthodox Church. Neither re-Baptism nor conditional Baptism is permitted. When being received into the Church, generally all that is required is that the person celebrate the Sacrament of Penance, make a Profession of Faith and receive the Eucharist.*
- b. *Episcopalian, Lutheran, Methodist, Anglican, Old Catholic, Polish National: If the fact of Baptism is certain, the Baptism is presumed to be valid. Neither re-Baptism nor conditional Baptism is permitted. When being received into the Church they are to celebrate the Sacrament of Penance, be confirmed and admitted to the Eucharist.*
- b. *Please consult the Office of the Chancellor for assistance in determining the validity of Baptism in other denominations.*

NOTE TO THE INTERVIEWER: *It is extremely important that the status of the inquirer's marriage be established AS SOON AS POSSIBLE. Many marriage situations are complicated and could require a year or longer in order to be resolved. Please make certain that the inquirers understand that these questions need to be **answered honestly**, with **absolute certainty**, and as early in the process as possible, so that the parish and/or the Diocese can assist them in their desire to become Catholic.*

When the inquirer is presently married and this is the FIRST MARRIAGE FOR BOTH the inquirer and spouse:

If **either** the inquirer or the present spouse is a **CATHOLIC**, and they are **VALIDLY** married to each other in the eyes of the Catholic Church, please provide a Catholic certificate of marriage.

If **either** the inquirer or the present spouse is a **CATHOLIC**, and they are **NOT** validly married to each other in the eyes of the Catholic Church, please have them **IMMEDIATELY** contact the parish priest or deacon to make the necessary arrangements for a **CONVALIDATION** of the marriage.

If **both** the inquirer and the present spouse are **NON-CATHOLICS**, in most cases, the marriage is presumed to be **VALID**, even if it did not take place with a religious ceremony. **HOWEVER**, in the case of a marriage where one of the parties is a member of an **ORTHODOX CHURCH**, please consult the parish priest or deacon to determine the validity of the marriage.

When the inquirer is presently married and there is a PREVIOUS MARRIAGE FOR EITHER the inquirer or the present spouse:

If the inquirer and/or present spouse were ever married to any person who is **STILL LIVING**, it is necessary to consult with the parish priest or deacon regarding the necessity of a **TRIBUNAL PROCESS**. Most marriages among non-Catholics are presumed to be valid, and therefore **REQUIRE** a Catholic Church annulment from the Tribunal, even if there has been no religious ceremony. This includes marriages which may have been granted a divorce or annulment by the state or another religious faith (e.g. Jewish Get, Orthodox dissolution). Since it is reasonable to anticipate a minimum of a year for the Tribunal process, the inquirer should be informed that the RCIA process will most likely extend to **AT LEAST** the following Easter Vigil.

If the inquirer has been married before:

- ▶ and the **former spouse(s)** are deceased, the inquirer will be free to marry in the Catholic Church provided that there are no other impediments to marriage.
- ▶ and any **former-spouse(s) are still living**, the inquirer **will be required to contact the Tribunal**, before entering a new-marriage in the future.

If the inquirer has NOT been married before:

- ▶ and is **currently engaged to be married**, the INTERVIEWER should contact a priest or deacon of the parish IMMEDIATELY so that the inquirer can begin the process of marriage preparation. Also, if the inquirer should become engaged during the RCIA process, they should contact the priest or deacon of the parish to begin the process of marriage preparation.
- ▶ and is **currently co-habiting with someone**, the INTERVIEWER should use this opportunity to present the inquirer with the moral teaching of the Church in this regard. It is a disservice to the couple and to the Church simply to ignore the fact of their living together, since it may give the impression that the Church condones this practice (cf.. Diocese of Brooklyn Marriage Guidelines).
